

MEMORANDUM OF UNDERSTANDING
For Academic Cooperation
Between
Central University of Haryana
and
Adarsh Mahila Mahavidyalaya, Bhiwani

The MEMORANDUM OF UNDERSTANDING (hereinafter MOU) is made and entered into on between the Central University of Haryana, having its premises at Jant-Pali, Mahendergarh, Haryana, India 123031 [hereinafter called **CUH/First Party**] on the ONE PART and the Adarsh Mahila Mahavidyalaya, having its premises at Circular Road, Hansi Gate, Bhiwani, Haryana 127021 (hereinafter referred as **AMM, Bhiwani/Second Party**) on the OTHER PART.

The MOU is in line with the NEP 2020, furthering its directives of strengthening the cooperation among the educational institutions in the country and utilizing the available resources for the benefits of the students in academics and the society at large.

The parties having discussed fields of common academic areas and allied activities between the two institutions have decided to enter into long-term collaboration for promotion of students in academics and allied areas.

Both parties agree in writing to participate jointly in the projects to fulfill the common academic objectives.

Article 1. Scope

- 1.1 Laboratories and library facilities available with the First Party and the Second Party will be made available to the faculty and students. However, the costs of specific consumables will be borne by the respective organizations.
- 1.2 In general, the First Party being an established central institution would play the role as a mentor to Second Party for continual improvement wherever feasible for the First Party.
- 1.3 Both parties would be able to jointly organize collaborative workshops, seminars, trainings, FDPs, conferences. Event wise necessary mutual agreement for sharing the responsibilities would be decided separately.
- 1.4 There shall be exchange of faculty and students for academic and training purposes with the consent of both the parties.

Article 2. Management

- 2.1 Registrar of First Party and Principal of Second Party will be responsible to mutually approve operational details between the two organizations.
- 2.2 The Advisory Committee (to be constituted on mutually agreed terms) will meet offline or online at least once in a year to review the activities.

Article 3. General Provisions


- 3.1 Both parties acknowledge that exchange of students from one party to the other shall be subject to the availability of funds and shall comply with the relevant regulations and policies of the First Party and the Second Party.
- 3.2 All questions related to this MOU arising during this term will be settled by the parties by mutual agreement.
- 3.3 All questions not foreseen related to this MOU will be handled by the parties by mutual agreement.
- 3.4 Advisory groups may also be formed by both the parties for smooth functioning to achieve objectives of this MOU.


Article 4. Entry into effect, modification and termination


- 4.1 This MOU shall become effective on the date it is signed by the parties and shall be valid for three years. The period of validity of this MOU may be further extended by mutual consent.
- 4.2 This MOU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least one month in advance from the effective date of termination.
- 4.3 All joint activities not completed at the expiration or termination of the MOU may be continued until their completion under the terms of this MOU.


The MOU has been executed in two originals, one of which has been retained by the First Party and the other by the Second Party.




