Minutes of Meeting held on 19-April-2025


A regular meeting of IQAC was held on 19 April 2025. All the agendas of the meeting were discussed and the minutes of the meeting are as follows:

1. For compulsory internship as per NEP Scheme, it was decided that a group of 15-20 students will be allocated to teachers. Teachers will give options to the students for internship after 2nd semester or after 4th semester. Students will have the option of doing internship from a company or a project under the mentorship of the faculty guide.
2. To increase the student's strength, following discussions were done-
 - a) To give advertisement in newspaper & local news channel
 - b) To constitute a counselling committee to motivate & guide the students.
 - c) Furthermore, college will telephonically contact the 12th pass out students and their details have already been collected by the college.
3. For ad-on and certificate courses, it was discussed to promote 10 days or 1 month courses, like beauty & wellness, Zumba, Kathak classical dance and computer related courses like AI.
4. Regarding discrepancies in syllabi of NEP 2020, it was discussed that work is already in progress and next week a mail will be sent to the university regarding all the discrepancies.
5. Further it was also discussed that AQAR for the session 2024-25 will be filled in the upcoming session and for that start working from the month of July-August.
